APPROVAL OF MINUTES

TRIBE REPORTS

Cherokee of Georgia Tribal Council: Provided by Paul Brannen. Spring PowWow is coming up April 4-6. Expect inkless fingerprint ID kits to arrive in the next couple of weeks. Getting language program started.

Lower Muskogee Creek Tribe: Provided by Chief Vonnie McCormick.

- Ending one year grant for language class. New beginner's class to start in the next couple of months. Current class to continue as well.
- Greenhouse number one has new doors and number two will have new doors soon. Security and wifi to be added to both.
- Tribal address to be corrected in law per HB 43 passing.
- Working on getting tribal records digitized with Valdosta State University.
- Three members providing translation help to University of Georgia.
- Tribe received 1,500 inkless fingerprint ID kits.

- Held First Berry
- Provided insight about a situation at Fort Scott where archaeologists dug into American Indian burial areas. Christian directed to connect with State Archaeologist about this matter.
